**REQUEST FOR BOAT DECAL - GENERAL BOAT/RAFT RULES**

- No person shall operate on the waters or ice of ELPOA any boat, raft, canoe, snowmobile, Jet Ski, or any type of vehicle or item driven or powered by an internal combustion, inboard, or outboard gasoline or kerosene engine. This prohibition, however, shall not apply to ELPOA officers or agents performing services for ELPOA, as authorized by the Board of Directors.
- Only one electric motor per vessel allowed, not exceeding 80lbs of thrust (Refer to motor guidelines if vessel falls within the Pontoon/Large boat guidelines).
- No electric jet skis of any type are allowed on ELPOA water.
- Row boats, kayaks, canoes, sailboats, and paddle boards fall under general boat rules and cannot exceed 17 feet long by 6 feet wide. All other boats must be inspected by the Boats, Rafts and Access Points Committee to determine if the boat falls under general boat rules, pontoon/large boat rules, or cannot be placed on either Erskine or Upper Erskine Lake.
- Boats of any size may not be tied together and floated as a permanent raft or dock.
- Any boat on ELPOA water or property must be identified with the current year ELPOA decal.
- Boat not displaying a current ELPOA decal must be removed from the lake.
- Any boat displaying a decal more than two years old will be considered abandoned.
- Swimmers and non-powered vessels have the right of way over any vessel powered with an electric motor.
- All ELPOA waters are considered a no wake zone regardless of the type of vessel.
- No overnight mooring in the water of boats or rafts at the Access Points.
- Rafts must be anchored and not have a motor.
- Anchored rafts require a decal.
